You release, indemnity and hold MerriMutts Inn harmless from any and all manner of damages, claims, losses, liabilities, cost or expenses, causes of action or suits, whatsoever in law or equity (including, without limitations, attorney's fees and related costs) arising out of or related to the services provided by MerriMutts Inn, except which may arise from the sole gross negligence or intentional and willful misconduct of MerriMutts Inn, including, without limitation: a)any inaccuracy in any statement made by yourself or information provided by you to MerriMutts Inn, b)your dog, including but not limited to destruction of property, dog bites and transmission of disease, and c)any action by yourself which is in breach of the terms and conditions of this Agreement.
